

APPL 692: MCS MARKETPLACE THEOLOGY FIELD IMMERSION CONTRACT
(Effective June 2010)

Definition:

Students completing an MCS in Marketplace Theology must undertake two terms (8 months) of supervised field immersion focused on marketplace ministry (APPL 692). This guided experience involves having a supervisor in the context of service as well as regular meetings with the Mentor in Marketplace Ministry from Regent College. This may be undertaken in a remunerate work context, a not-for-profit enterprise or a church, provided in the last case it is a specific assignment concerned with marketplace ministry in the church (equipping people for their service in the dispersed life of the church). Please see the APPL692 syllabus for further details.

N.B. International students in the Marketplace Theology concentration may be eligible for a Canadian Work Permit to enable them to undertake remunerated work outside the UBC Campus and thereby fulfill the requirements of this course. See further note below.

Registration:

In order to register for the Marketplace Theology Field Immersion, the Student must submit a completed Field Immersion Contract to the Registrar’s Office, together with a Registration Form or (if already registered for the term) a Course Change Form. Students should make a copy of this Contract for their own records. In Fall and Winter terms, Field Immersion Contracts may be added up to the end of the third week of the term. Field Immersions must be completed by the last day of the term following the one in which they are registered (see terms below). If not completed by this date, the Student must apply for an extension by the last day of term in order to complete the field immersion.

Terms:

1. Normally Field Immersion will be undertaken over two terms (Fall and Winter, or Winter, Spring and Summer, or Spring, Summer and Fall – counting Spring and Summer together as one term). Each of the two terms will receive 1.5 credit hours for a total of 3.
2. Field Immersions are subject to availability of suitable field immersion opportunities. Students are expected to take initiative in securing such opportunities. Regent College does not guarantee to find employment for the student though the College’s Mentor in Marketplace Ministry will seek to match the student’s interests with available opportunities.
3. Although the Student’s field immersion may involve work outside of Regent College, the College assumes no liability for injury, loss or damage to the Student incurred during the course of the field immersion, and the Student agrees hereby to hold harmless and fully indemnify Regent College for any injury, loss or damage occasioned to the Student or a third party arising from the Student’s work in the field immersion.
