#### **Course Description**

As the aging of society is now progressing, the role or lack of role of its 'seniors' will become a serious burden for church and society alike. Yet Biblically, the church should see the role of 'elders' as the dynamic of its spiritual health; instead our hope lies in a youth culture. Facing the medical consequences of advancing bodily health, are churches prepared for the rapid increase of 'seniors' who have never been equipped to be 'elders'? Such is the challenge of this course. While the course is primarily intended for pastors, Christian leaders, medical and nursing care-givers, it is also an open challenge to Christian youth to accept new paradigms in discipleship.

### 2. Research Essay (2-credit hour students only)

Two-credit hour students are to write a paper investigating one of the topics of the course in more detail. The final product should be 3,750 words in length. Students may either write a typical research essay, an experiential activity paper (incorporating 15 hours of activity such as interviewing older members of the student's church, speaking with caregivers of people with Alzheimer's, or visiting a senior care facility and reflecting on the setting), or a combination of the two.
