### **CHURCH GROUP BENEFIT AND REGISTRATION FORM**



WINTER TERM 2026

The Church Group Benefit gives each student within a church group 25% off their credit or audit tuition. The intention of this benefit is to allow church groups to learn and grow alongside each other, blessing their congregation by enriching and deepening their life together. In turn, this benefit blesses the whole body of Christ.

To apply for this benefit, a church representative must sign and submit this form by the deadline specified below. Participants need to create an online Regent student account through REGIS and register for their course(s) there. After, this Church Group Benefit form must be submitted either in person at reception or via email to registration@regent-college.edu by the deadline below. Payment for all students must be made in full before registration can be completed (see below for more information). A \$50 administrative fee will be applied to each student if registration and payment are received after the deadline.

#### **DEADLINES**

For the January Intensive courses (Jan 5-9), the deadline to register is Friday, January 2, 2026 while for regular courses, the deadline to register is Friday, January 9, 2026. For the weekend courses APPL/INDS 570 and SPIR/THEO 635, the deadline to register is Friday, January 23, 2026. Payment must be received for the group by the respective registration deadlines. Payments received after the registration deadline will be subject to a \$50 late payment fee.

#### **ELIGIBILITY**

- **01/** The benefit is available only to participants from the same congregation who attend as a group of 3-10 people.
- 02/ The benefit applies to all courses except pre-recorded distance education courses, conferences, guided studies, seminars or off-site or enroute courses.
- **03/** This benefit cannot be combined with any other tuition benefit in the same course; however, students who would like to use the 50% Senior Audit or 50% Graduate Audit benefits can still count toward the minimum number of the group (see above).
- 04/ A group may not include more than two students currently enrolled in a program at Regent College.
- **05/** No person may use the benefit more than once.

#### REGISTRATION AND BENEFIT CALCULATION FORM

Each participant needs to establish a REGIS account for registration and benefit processing. Go to <u>rant.net/regis</u> and LOG IN to REGIS to create a student ID # account. Please fill out the form below to calculate the final amount owing. As noted above, full payment for the entire group must be submitted via a single payment. Winter 2026 tuition fees are \$545/\$565 per credit hour (on-campus/online) and \$400/\$420 per audit hour (on-campus/online). The Church Group Benefit's 25% reduction has been calculated in the form below. The 25% reduction does not apply to additional fees.

Note: Current Regent Students who are eligible for AMS Membership and the U-Pass Benefit should arrange to pay for their associated fees separately (see the student contract to check eligibility). If these fees are not paid by the deadlines outlined in the student contract, these students may be dropped from their courses.
