HIST 541: THE STORY OF CHRISTIANITY IN CANADA

COURSE DESCRIPTION

This class surveys the history of Christianity in Canada primarily through biographical sketches that illuminate key aspects of that history. Individuals highlighted will include church officials (like Bp. Louis-Francois LaFleche, Bp. Charles Inglis, and Rev. Nathanael Burwash), popular preachers (like Henry Alline and Aimee Semple McPherson), Indigenous leaders (like Joseph Brant and Louis Riel), public intellectuals (like Egerton Ryerson and George Monro Grant), scholars (like George Grant and George Rawlyk), literary figures (like Robertson Davies, Margaret Avison, and Margaret Clarkson), and others. The class will assess the national situation when Protestant and Catholic varieties of the faith prevailed throughout the nation, and then the rapid secularization of recent decades. The goal is increased historical understanding, but also exploration of possibilities for faithful witness in the present.

LEARNING OBJECTIVES

Upon the successful completion of this course, students should have a clearer understanding of:

- 1. Understand some of the main issues, people, denominations, and problems in the Canadian history of Christianity
- 2. Make an intelligent comparison of that history with the parallel history of Christianity in the United States.
- 3. Consider ways that historical understanding may shape Christian life, practice, and outreach in Canada today.
